INVITATION OF BIDS For Supply and Installation of Real Time PCR System

Tender No. SAU/SP/FLSB/2019/08 dated 28.06.2019

The South Asian University (SAU) is an International University sponsored by the eight member countries of the South Asian Association for Regional Cooperation (SAARC) viz. Afghanistan, Bangladesh, Bhutan, India, Maldives, Nepal, Pakistan and Sri Lanka.

The University invites sealed Bids from reputed authorized distributors/dealers/retailer etc. for Supply & Installation of Real Time PCR System under following specifications at Faculty of Life Science & Bio-Technology of the South Asian University:

Real Time PCR System

 The system should be an automated & integrated system for both real-time PCR and post-PCR (end-point) analysis with following features:

Hardware:

- 2. The system should be 96-well block system with Peltier based heating & cooling.
- 3. The excitation source should be LED/Laser and data acquisition should be simultaneous and scan-free for whole plate acquisition.
- 4. The system should have 4 filters and come along with fixed (scanning free) optics, ensuring robust data.
- 5. The system should have temperature range of 37°C 98°C to facilitate all qPCR applications.
- 6. The system should have peak block ramp rate for exceeding 6.5°C/second or more.
- 7. The system should have 3 separate Peltier controlled block to run minimum three samples with maximum 10°C difference in annealing temperatures across the block for running multiple experiments simultaneously in single run.
- 8. System should support reaction volume minimum of 10µL in 0.2ml tube.
- The system should be a standalone system i.e. it should have advance Touch Screen LCD feature to avoid dependency on computer for operation with up to 10GB onboard memory of at least 1000 runs with USB.
- 10. Fast-PCR in less than 35 minutes should be an integral feature of the system.

Software:

11. The instrument should have software that can analyze multiple perspectives in the Multiple Plots view, with side by side views of all data aspects including the amplification plots, standard curve, multicomponent data plots, and raw data. The system should give heat map of the amplification & analyzed data. Software should have PCR efficiency factor correction for gene quantification.

- 12. The system should along with software to support applications including absolute quantitation, Relative quantitation, multiplex-PCR, allelic discrimination (SNP), melt curve analysis as well as pathogen detection, plus/minus assay using internal positive control & mutation screening.
- 13. Instrument must be MIQE compliant and capable of Real-time PCR data markup language (RDML) export format.

Supporting Chemistries and Applications:

- 14. The system should be completely open system to support all the Real Time PCR chemistry like TaqMan, SYBR Green, Simple & Hydrolysis Probes, and Molecular Beacons etc.
- 15. The system should be capable of detecting even 1 copy in a single reaction tube without passive reference dye. However normalization of reaction due to non-PCR related fluctuations should be possible by using any calibrated dye.
- 16. The system should be open system with flexibility to use micro well plates, individual tubes and 8-tube strips.
- 17. System should detect differences in target quantity as small as 1.5-fold in single plex reactions, and should have 10 logs of linear dynamic range.

Terms & Conditions:

- 18. The instrument should come along with 03 years of warranty with 01 calibration kit. Should be supported with remote services, cloud connectivity online monitoring, and external barcode using USB etc.
- 19. Should be provided with 2 KVA UPS of Emersion/APC make with 30mins backup, branded laptop for data analysis with window based software package.
- 20. Company must have NABL Accredited lab in Delhi NCR with full license for PCR process and attach a list of minimum 40 installations.
- 21. Firm MUST provide a compliance statement vis-à-vis specifications in a "tabular form" clearly stating the compliance and giving justification, if any supported by technical literature with clear reference of page number, paragraph or lines. This statement must be signed, with the company seal, by the Tendered for its authenticity and acceptance that any incorrect or ambiguous information found submitted will result in disqualification of the Tender.

Terms & Conditions for Submission of Bids

1. The Bid must be made in a duly sealed and signed cover with the Contract Name and Tender Number at the top left corner of the envelope and submitted to the Assistant Registrar, Stores & Procurement Section, Room No. 424 4th Floor, South Asian University, Akbar Bhawan, Chanakyapuri, New Delhi-110021 or submitted at the Reception of South Asian University. The university assumes no responsibility in respect of a bid not made and/or not submitted as required.

- The Bid must reach the university no later than 3:00 PM on 15.07.2019. South Asian University (the purchaser) may reject any late submitted bid. All timely-received bids are scheduled to be opened on the same day at 3:30 PM.
- 3. In the event of the due date of receipt and opening of the tender being declared as a holiday for the University, then due date of receipt/opening of the tender will be the next working day at the same time.
- 4. Bids shall remain valid for a period of sixty (60) days after the bid submission deadline date.
- 5. The bidder is required to submit an Earnest Money Deposit, refundable without interest, of Rs. 60000.00 (Rupees Sixty Thousand only) in the form of demand draft/Pay order drawn on any scheduled banks in favour of "South Asian University" payable at New Delhi. NSIC & other exemption certificate will not be accepted as EMD. Bids will be summarily rejected if not accompanied with the required EMD.
- Earnest money is liable to be forfeited and bid is liable to be rejected, if the bidder withdraws or amends impairs or derogates from the tender in any respect within the period of validity of the tender.
- 7. All bidders are required to read these conditions carefully and while sending their tender should enclose a copy of the conditions stipulated duly certified and attested by them in token of accepting the tender conditions that they understood and accepted them in full. Tenders received without the certified copy of the conditions shall be rejected summarily.
- 8. The Bid shall be typed or written in English with indelible ink and shall be signed by a person duly authorized to sign on behalf of the vendor. Official Stamp should be placed after the signature.
- 9. The Bidder is expected to examine all instructions, forms, terms and specifications in the bidding documents. Failure to furnish all information required by the bidding documents or submission of a Bid not substantially responsive to the bidding documents in every respect will be at the Bidder's risk and may result in rejection of the bid.
- 10. The bid proposal must be properly indexed and bound and all the pages shall be signed and stamped. Any loose document submitted by bidders will be rejected.
- 11. Price of each item should be indicated in the format of price schedule given in Annexure I. The applicable tax/ duty shall be indicated separately. Any additional charges to be levied should be clearly specified. The vendor shall quote only in Indian Rupees.
- 12. Prices quoted by the vendor shall be fixed during the vendor's performance of the Contract and not subject to variation on any account.
- 13. Alternative offers/partial offers shall not be considered. The vendors are advised not to quote different options for the same item but, furnish the most competitive among the options available to

the bidder. A Bid submitted with an adjustable price shall be treated as non-responsive and may be rejected.

- 14. Losses or damages in transit will be to the account of the supplier. No payment will be made in advance for any supplies under this tender.
- 15. The University reserves the right to verify/seek confirmation of all original documentary evidence submitted by the vendor's in support of tender, specification, etc. in case any information furnished by the vendor is found false/incorrect the tender of the vendor will be rejected.
- 16. All material purchased here under must be packed to ensure its safe delivery in accordance with good commercial practice. It is sole responsibility of the vendor to provide/replace the item/good if it is lost or broken during the shipping or transportation due to whatever may be the reason.
- 17. All hardware & software including drivers, device interface cards/network adaptor card must be pre-installed & pre-configured. Hard copies of instructions/operations/service manuals should also be supplied.
- 18. The vendor shall have to indemnify, hold harmless and defend the University, its employees, and students with respect to all claims, suits, actions and proceedings of trademark or trade name, trade secret, copyright or other protected right in any country resulting from any sale, use or manufacture of any material delivered hereunder and to pay and discharge all judgments, decrees, and awards rendered therein or by reason thereof and bear all expenses and legal fee (including the University) associated herewith. The University reserves the right to be represented in any such action by its own counsel at its own expense.
- 19. Original company literature from Principal Company/ Manufacturer must be supplied, clearly verifying all specification.
- 20. The bidder should clearly specify make and model of the machine in their respective bid.
- 21. At any time prior to the due date for submission of bids, the Purchaser may, for any reason, whether at its own initiative or in response to a clarification requested by a prospective bidder, modify the bidding documents by amendment which will be displayed at University's website.
- 22. A firm having any legal suit/criminal case pending against its proprietor or any of its Directors (in the case of Private Ltd. Company) or having been earlier convicted on grounds of moral turpitude or for violation of laws in force shall not be eligible. A self-declaration to this effect shall be furnished by the bidder.
- 23. The University has the right to reject any Bid, and to annul the process and reject all Bids at any time prior to acceptance, without thereby incurring any liability to bidders and without assigning any reason.

- 24. The University will accept the Bid of the vendor whose offer has been determined to be the lowest evaluated bid and is substantially responsive to the documents issued.
- 25. Any effort by a Bidder to influence the University in the examination, evaluation, comparison, and post qualification of the bids or contract award decisions may result in the rejection of its bid.
- 26. To assist in the examination, evaluation, comparison and post qualification of the bids, the University may, at its discretion, ask the Bidder for a clarification of its bid. The request for clarification and the response shall be in writing and no change in prices or substance of the bid shall be sought, offered or permitted. However, no negotiation shall be held except with the lowest bidder, at the discretion of the purchaser. Any clarification submitted by a bidder in respect to its bid which is not in response to a request by the University shall not be considered.
- 27. Goods shall be supplied & installed within 4 weeks from the date of purchase order. The date of supply and installation shall strictly be adhered to, failing which the University reserves the right of not accepting the supplies and to charge suitable damages or to effect purchase at the supplier's cost and risk. If the supplier fails to supply and install the goods on or before the above mentioned period, compensation may be recovered at the rate of 1% of the cost of order for every weeks delay or fraction thereof, subject to a maximum of 10% of the cost of goods. If and when required, the extension for date of delivery should be obtained with proper justification. Part supplies will not be accepted.
- 28. PERFORMANCE SECURITY: Performance security of 5% of the total value of the contract may be furnished within 2 weeks of the purchase order in the form of an Account Payee Demand Draft/ Fixed Deposit Receipt/or a Bank Guarantee from any Scheduled Commercial Bank in an acceptable form to the University drawn in favour of South Asian University, payable at New Delhi. Performance security shall remain valid for a period of sixty days beyond the warranty period. No interest will be payable by the University on Performance Security.
- 29. Onsite Warranty Support & Service: The instrument should come along with 03 years of warranty with 01 calibration kit. Should be supported with remote services, cloud connectivity online monitoring, and external barcode using USB etc.
- 30. **Penalty**: For issues or problems that are not resolved onsite by the next business day, 0.5% of performance security amount will be charged as penalty per day, subject to a maximum of 10% of the security amount. Repeated failure to provide timely onsite support or undue delay by bidder in the performance of its contract obligations can attract forfeiture of performance security and termination of contract/work order for default.
- 31. The payment will be made 100% within 30 days after supply and installation of all goods against the particular order to the satisfaction of the University.
- 32. Matters regarding any dispute shall be referred for arbitration to any Officer appointed by the President of SAU, whose decision shall be binding and final.
