NOTICE INVITING BIDS

Bids are invited on behalf of the President, South Asian University, under Two-bid system (Technical bid and Financial bid) from reputed, eligible and qualified firms for Shifting/relocation of various Office Furniture, Library, Computer Labs, Hostel, Classrooms, Mess, Cafeteria, Servers and UPS etc. from South Asian University, Akbar Bhawan, Chanakyapuri, New Delhi to Permanent Campus of South Asian University at Maidan Garhi, New Delhi as per schedule, specifications and as per the terms & conditions mentioned in this document.

1. NAME OF WORK

- 2.2. Last date of Bid submission: 12.12.2022 (12 December 2022) till 11:30 AM
- 2.3. Opening of Bid: 12.12.2022 (12 December 2022) at 12:00 Noon

3. PRE-QUALIFICATION CRITERIA

- 3.1. The tenderer must be a reputed agency.
- 3.2. The tenderer should have average annual turnover of not less than Rs. 25 lakhs for the last three years.
- 3.3. The tenderers should have completed at least; Three similar works each of value not less than Rs. 10 Lakhs

Two similar works each of value not less than Rs. 15 Lakhs

OR

One similar works of value not less than Rs. 25 Lakhs

in the last 3 years (i.e. Similar work means shifting of same nature of items in any other Govt. Department, Public or Private universities/institutions, Research organizations during last three years). Attested copies of the completion certificates issued by the officer-in-charge or above are required to be enclosed with the technical bid. The tenderer should also give complete details of the concerned authority such as name with designation, valid address, telephone/ mobile number with STD Code to verify the works done. The completed works in case found to be not up to the standard during the verification, such tender of the tenderer will summarily be rejected & no queries will be entertained in this regard (enclosed details in **ANNEXURE – III**).

The firm should have not been blacklisted, debarred, declared non performer or expelled from any work of Union Government/ State Governments/ PSUs/Universities etc. during the last 5 years. They should also submit a notarized affidavit for the same. The applicant should also provide information regarding litigation / arbitration cases for the last five years, if any.

The tenderer can visit the site and its surrounding to assess the accessibility and asses the scope of work before submitting their offer. No claims later on shall be entertained. The tenderers shall arrange & maintain at his own cost all materials, T & P, Water and facility for workers for executing the work (enclosed detail in **ANNEXURE – VIII**).

4. SUBMISSION OF BIDS

- 4.1. Under the two bid system, the bidders are required to submit their 'Technical bid' and 'Financial bid' separately. All the documents related to technical bid (i.e Eligibility criteria & technical details) and financial bid should be put in two separate envelopes duly marked as 'Technical bid' and 'Financial bid' respectively. Both the envelopes shall then be sealed in one outer (main) envelope which should be super subscribed clearly with the name of tender and number addressed to the President, South Asian University, and New Delhi. The outer envelope shall contain the name and postal address of the tenderer with Phone/ Mobile/ Fax numbers and e-mail address.
- 4.2. The 'Technical bid' should consist of the following documents:
- a. Application form along with documents relating to eligibility criterion (as per Annexure I to VII)
- b. Bid Security (EMD)
- c. Complete Tender Document duly signed and stamped
- 4.3. The 'Financial bid' should contain the following documents:
- a. Price bid as per the prescribed format at annexure II.
- 4.4. Bid should be valid and open for acceptance for a period of 90 days from the date of opening the technical bid.

5. PRE-BID MEETING

A pre-bid meeting with all the prospective bidders will be held as per the schedule in Room no. 408, South Asian University, Akbar Bhawan, Chanakyapuri, New Delhi. Interested applicants/ firms are invited to attend the same with a written statement of their query. Corrigendum/amendments etc., if any, will be notified only on the http://sau.int. No separate advertisement will be made for the same. All prospective bidders are therefore advised to visit the mentioned place for any future information or update.

6. OPENING OF TECHNICAL BID.

Technical bid shall be opened at South Asian University, Akbar Bhawan, Chanakyapuri, New Delhi on due date.

7. EVALUATION OF TECHNICAL BID

- 7.1. Screening of pre-qualification documents
- 7.2 Further, the bids will be evaluated for compliance with the minimum pre-qualification criteria as listed above. The screening will be done purely on the basis of documentary evidence submitted by the tenderer along with his technical bid.
- 7.3. The decision of Bid Evaluation Committee as regards to the evaluation of bids will be final and no correspondence will be entertained in this regard.
- 7.4. The firms who qualify as per the technical bid will only be considered for opening of its financial bid.

8. OPENING OF FINANCIAL BID/PRICE BID

- 8.1. The price bid of final short listed bidders only will be opened at a date and time to be decided by the competent authority.
- 8.2 Evaluation of price bid and award of work shall be done thereafter.
- 8.3. The work will be awarded to the bidder whose bid has been offered the lowest price.

9. TERMS AND CONDITIONS OF THE BID

The interested firms may submit their bids for the above mentioned work at the South Asian University, Akbar Bhawan, Chanakyapuri, New Delhi. The bids received without EMD are liable to be rejected.

10. SCOPE OF WORK

The scope of work covered under this tender shall include relocation of various Office Furniture, Library, Computer Labs, Biotechnology labs and workbenches, Hostel, Classrooms, Mess, Cafeteria, Servers and UPS etc. from South Asian University, Akbar Bhawan, Chanakyapuri, New Delhi to Permanent Campus of South Asian University at Maidan Garhi, New Delhi. The indicative details of such items are enclosed at

ANNEXURE – IX & X. Interested contractors/parties should visit the site of the present location on prebid dates to assess the exact nature of requirements before submitting their bids.

ICT Hardware

The scope of work shall also include Dismantling (unmounting from racks or electrical outlets), Packing, Loading, Shifting, Unloading, Unpacking and Re-Installation (mounting into racks or electrical outlets) of all hardware devices mentioned below as per instructions by the designated site in-charge. The indicative list of such items are enclosed at **ANNEXURE-X**. Interested contractors/parties having required technical expertise in such shifting should visit the site of the present location on pre-bid dates to assess the exact nature of requirements before submitting their bids.

I. RESPONSIBILITY OF THE BIDDER

- 1.1. Packing and unpacking of all items as per instructions of the respective site in-charge.
- 1.2. Transport arrangement with deployment of suitable vehicles i.e. under sealed container trucks during days of shifting including adequate labour, machinery via fork lift/trolleys etc. as required.
- 1.3. Experienced **labour** as required to handle sophisticated and sensitive equipment under their supervisor deputed for the work.
- 1.4. Special and sophisticated support machinery such as hydraulic, chain pulley cranes and other machinery, if required, for loading and unloading, transfer of heavy equipment's and trouble free installation at the required site, as per the instructions of the respective site in-charge.
- 1.5. The goods to be wrapped with ballooning paper, HM Laminated Foams, corrugated Sheets, Thermocol sheets, air bubble wrapping material, water proof, moisture free, wherever is required so that the goods can easily withstand jerks while shifting and are delivered to the destination without any scratch, damage, breakage.
- 1.6. While re-location of the office goods & other equipment and loading equipment, agency should ensure that all equipment, files, furniture & other equipment have to be moved and set up on scheduled date, time and place.
- 1.7. Place the equipment in position at designated location as directed by representative of SAU in the new building.
- 1.8. Arrangement of thread, ropes, adhesives, ladders, sticky tapes etc. wherever required.

- 1.9. The tenderer should arrange Traffic permissions from DCP Office, Chanakyapuri or wherever required prior to aligning transport arrangements.
- 1.10. Client Performance & Satisfaction Report. Tenderer should give the documentary proof of experience in providing successful packing, shifting & re-location Services in Central/State Government Department (including Public-sector companies / Autonomous bodies) Universities/ Research Institutions. EMD (Earnest money deposit) of Rs. 100,000 in favor of South Asian University.
- 1.11. Valid Registration no. of the Firm/company (attach attested copy of the Certificate)
- 1.12. Valid PAN No. of the Company/firm (attach attested copy of the PAN card) Valid Service Tax/GST Registration No. (Attach attested copy of the certificate)
- 1.13. The tenderer must have their own vehicles (5 vehicles) for transportation (Copy of Registration Certificate of vehicles to be enclosed).

1.14. Rates and Payments:

- A) The rates of the Agency shall include cost of all materials, labour, machinery and all taxes other inputs involved in the execution. No extra amount shall be paid from the quoted amount.
- B) In case shifting of items to upper floors through stairs, Agency shall make its own arrangement for shifting manually or by any other means like staging, making ladder or whatever required. Nothing extra shall be paid on this account.
- C) Only quoted rates in whole rupees shall be considered. Rates quoted in percentage terms will not be considered. Where the rates quoted by the Agency in figures and in words don't tally, in that event the rates quoted in the words shall be considered as correct and final.
- D) No advance payments will be considered. The Agency/Contractor should submit Tax Invoices in triplicate for payment quoting PAN No., TIN No. & GST No. on the body of the bill. The payment will be made by local a/c payee cheque or bank transfer only after producing the handed over certificate from the concerned officers. The payment shall be made after successful & satisfactory completion of work only.
- 1.15. Interested contractors should visit the sites of the present locations to assess the exact nature of requirements before submitting their quotes.
- 1.16. Shifting process and schedule will be supervised & monitored through the designated officer which includes Packing & Loading and further unpacking, Un- loading and relocation, The designated officer from SAU will supervise, instruct & Guide the agency about picking of desired items from existing building & shifting of the same.
- 1.17. The agency shall arrange to shift the items from the designated area to the new area within the date of intimation given to them. The shifting then shall be carried out as per schedule intimated. In case of default, Penalty at the rate of 0.2% of the ordered value of work per day will be imposed on the

agency. In the event of continued default for 7 days, the SAU may at its discretion cancel the contract. In the event of cancellation of contract, SAU reserves the right to forfeit the performance or guarantee submitted by the Agency without any notice.

- 1.18. The shifting has to be done carefully so that no damages are occurred, however, otherwise, liquidated damages will be recovered out of the payments.
- 1.19. The Agency will be solely responsible for safe & secure transit of Goods to the satisfaction of the SAU. In event of any damages, the loss will be charged by the SAU or in any other manner as deemed fit by the SAU.
- 1.20. The agency shall indemnify SAU against all loses it has suffered during any accident/incident during the execution of this job. Indemnity bond need to be submitted on 50-rupee stamp paper.
- 1.21. The Agency is required to take all safety and security measures of men and materials involved in the shifting process.
- 1.22. Any time after award of work, SAU may abandon or reduce the scope of work for any reason whatsoever and hence not require the whole or any part of the works to be carried out, the Agency shall have no claim to any payment of compensation or otherwise whatsoever.
- 1.23. During execution of the works the entire premises have to be kept clean and free from any obstructions, all the debris and surplus materials shall be removed from the work site as soon as works are completed.
- 1.24. The total work has to be completed in phases and preferably during office hours, agency has to arrange number of vehicles, labour, packing materials etc. accordingly. The successful bidder has to make agreement on 100-rupee Stamp Paper agreeing all the terms and conditions of tender document at its own cost.
- 1.25. In all matters, the orders/interpretation of the Competent Authority of the SAU shall be final & binding on the Agency.
- 1.26. In case of non-compliance of any of the clause/terms, the SAU will have the right to impose penalty as deemed fit, and engaged new contractors, and also forfeit the Performance Guarantee in full or in part.
- 1.27. The successful bidder shall have to deposit @ 5% of total value of work order as Security Deposit/Performance Guarantee at the time of award of contract which shall remain valid for 60 days and no interest shall be paid upon the same.
- 1.28. The SAU reserves the right to terminate the contract at any time without assigning any reason and also to refuse services of any contract worker of the firm without assigning any reasons.

II. ADDITIONAL INSTRUCTIONS TO BIDDERS

- 1.1. The bidder shall submit their bid at the South Asian University, Akbar Bhawan, Chanakyapuri, New Delhi-110021
- 1.2. The bidder may furnish any additional information, which he thinks is necessary to establish his capabilities to successfully complete the envisaged work. He is however, advised not to furnish superfluous information. No information shall be entertained after submission of tender documents unless it is called for by the SAU.
- 1.3. Any information furnished by the bidders found to be incorrect either immediately or at a later date, would render him liable to be debarred from tendering/taking up of work in SAU.
- 1.4. Any variation in the terms and conditions of the general/special conditions for payment, security deposit etc. is not acceptable to SAU and such tenders will be rejected straight away.
- 1.5. SAU reserves the right to award the contract in full or in part as per the decision of the competent authority.
- 1.6. The contractor has to inform contact no. and the person to be contacted in case of any query.
- 1.7. The tenderer shall attach the copy of PAN Card, TIN and GST registration.
- 1.8. Acceptance of tender shall rest with the SAU which shall not be bound to accept the lowest tender and reserves to itself the right to reject any or all tenders received without assigning any reasons therefore.
- 1.9. Incomplete tenders are liable to be rejected.

III. GENERAL CONDITIONS OF CONTRACT

- 1.1. SAU means South Asian University with its present office at Akbar Bhawan, Chanakyapuri, New Delhi-21 and its building at Maidan Garhi, New Delhi also.
- 1.2 The Contractor shall mean the sole proprietor or firm or company whether incorporated or not, undertaking the works and shall include the legal representative or such individual successors, heirs, administrators or assignees of such sole proprietor, firm or company, as the case may be or the persons composing such firm or company of the successors of such firm or company and the permitted assignees of such individual or firms or company.
- 1.3 Designated officer executive director of SAU who shall supervise and shall be in charge of the work, and issue necessary instructions at site, on behalf of SAU.
- 1.4 Contractor shall strictly conform to the price schedule, general and special terms and conditions, if any, and any other matter contained in the tender documents issued by the SAU.

IV. BID SECURITY (EARNEST MONEY DEPOSIT)

1.1. Earnest money along with the tender will be accepted in the form of demand draft drawn in favor of "South Asian University, New Delhi" drawn on a Nationalized/Scheduled bank. The demand draft shall be payable at New Delhi.

1.2. The bid securities of unsuccessful tenderer will be returned as promptly as possible as but not later than 30 days after the expiry of the period of bid validity prescribed by SAU.

1.3. The bid Security of the successful bidder will be returned upon the tenderer executing the work and furnishing the required Performance Security.

1.4 Withdrawal or modification of offer by the tenderer during the interval between the deadline for submission of bids and expiry of the period of bid validity will not be permitted and will result in the forfeiture of its bid security.

1.5 Bid Security (Earnest Money Deposit): Rs. 100,000

V. PERFORMANCE SECURITY

1.1. The contractor will be required to furnish performance security as per prescribed format for an amount equal to 5% of the estimated value of the work in the form of FDR/DD/bank guarantee (of nationalized/ Scheduled Bank in a standard format) within one weeks from the date of signing/execution of a work agreement. The performance security should remain valid for a minimum period of 60 days from the date of execution of work agreement.

1.2. The performance security will be released after 30 days after completion of work subject to satisfactory fulfillment of its obligations by the contractor under the work.

1.3. Failure of the successful contractor to lodge the required Bank Guarantee shall constitute sufficient grounds for the annulment of the Award and forfeiture of the Bid Security, in which event the SAU may make the Award to the next lowest evaluated tenderer or, if there are no other tenderer, call for new bids.

1.4. In the event of breach of contract by the contractor, the performance security will liable to be forfeited by SAU.

VI. TIME FOR COMPLETION OF WORK

The work will be awarded to the successful tenderer for a period of 01 month. All the work/contract orders placed under this work will have to be delivered and installed at site within a period from the date of issue of respective work/contract order.

VII. TIME AND EXTENSION OF WORK

1.1. If in the opinion of the Officer the works is delayed by:

a. Force majeure.

- b. Reasons of civil commotion, location combination of workers on strike or lock-out affecting any of the building trades.
- c. In consequence of the contractor for not having received in due time necessary instructions from the Officer for which he shall have specifically applied in writing.
- d. The Officer shall make a fair and reasonable extension of time for completion of the contract works. Then upon the happenings of any such event causing delay, the Contractor shall immediately give notice thereof in writing to the Officer-in-charge but shall nevertheless use constantly his best endeavors to prevent or make good the delay and shall do all that may be reasonably required to the satisfaction of the Officer to proceed with the works.
- 1.2. Request for rescheduling of date of completion and extension of time, to be eligible for consideration, shall be made by the Contractor in writing immediately after the happenings of the event causing delay. The Contractor may also, if practicable, indicate in such a request the period for which extension is desired.
- 1.3. In such case, the Officer may give a fair and reasonable extension of time and reschedule the completion date. Such extension shall be communicated to the Contractor by the Officer in writing within a week of the date of receipt of such a request. Non-application by the Contractor for extension of time shall not be a bar for giving a fair and reasonable extension by Officer and this shall be binding on the Contractor.

VIII. COMPENSATION FOR DELAY

Time is the essence of the contract. The time allowed for the work shall be strictly followed otherwise the Contractor shall be liable to pay compensation at the rate of 0.2 % of the ordered value of the work per day of delay on the part of the contractor subject to a maximum of 5 % of the total ordered value. The decision of Officer about the delay shall be final and binding.

IX. CO-ORDINATION

Work shall be carried out in such a manner that the work of other agencies operating at the site is not hampered due to any action of the contractor. Proper co-ordination with other agencies will be contractor's responsibility. In case of any dispute the decision of SAU shall be final & binding on the contractor.

X. CLEARANCE OF SITE

The contractor shall have to remove all waste (Melba) and other unwanted material from site of work before handing over the installation to the SAU. The work shall not be treated as complete in all respects unless these requirements are fulfilled by him. In the event of contractor failing to do so, the SAU shall have right to get the site cleared at the cost of contractor.

XI. SAFETY CODE, LABOUR CAMPS, SANITARY ARRANGEMENTS

The Contractor shall follow the Safety Code and Model Rules for the Protection of health and Sanitary arrangement for Workers as prescribed by the CPWD as regard to safety code and first aid facilities. In case, the Contractor fails to make the aforesaid arrangement, the SAU shall be entitled to do so at the risk, responsibility and cost of the Contractor. Determent panel and legal action shall be taken in the event of any failure on the part of the contractor to discharge the safety obligations which are laid down in the contract.

XII. PAYMENT OF WAGES BY THE CONTRACTOR

The Contractor shall directly pay all the labour employed by him and shall be solely responsible for following all Government rules and regulations applicable for employment.

XIII. REMOVAL OF PERSON DEPLOYED FOR WORK

The Officer may require the Contractor to remove from the site of the work any person or persons in the Contractor's employment who may found to be incompetent or due to misconduct and the Contractor shall forthwith comply with such requirement / instructions.

XIV. WATCH AND WARD

The contractor shall be responsible for watch and ward of all the works, Lab Furniture Items and various materials till complete handing over the works / Lab Furniture and equipment Items to the SAU.

XV. OTHER CONDITION

- 1.1. Orders under the contract will be made separately by SAU for execution of specified works. Bills may be submitted against the respective work order for payment to the respective institution.
- 1.2. No advance/part payment will be made. Payment will be made on completion of the work as per orders issued.
- 1.3. Payment term: the running bill will be paid normally within 30 days against the actual work done.
- 1.4. The submission of tender shall be deemed to be an admission on the part of the bidder that it has fully acquainted with the contract terms and no claim other than what stated in the tender shall be paid in the event of award of Contract.
- 1.5. The successful tenderer is responsible to provide the required manpower with qualified persons to meet the requirements of the maintenance of the installation during the guarantee period. The contractor shall provide any cleaning materials required. Tools required for the maintenance shall be arranged by the contractor viz. spanner set, cutting pliers, pipe wrenches etc.
- 1.6. The staff to be engaged on this work shall have full knowledge and experience of the work in which they are engaged.
- 1.7. No subletting or subcontracting of the work will be permitted without the express consent of SAU.

- 1.8. The tenderers should have competent personnel stationed in the office in Delhi/NCR. The office in Delhi/NCR must also stock spares for providing prompt services during the guarantee period and thereafter if required. A proof to this effect must also be furnished.
- 1.9. All disputes arising under this contract will be subject to the jurisdiction of Delhi High Court.

XVI. SPECIAL CONDITIONS OF CONTRACT

1.1. PRICE

Tenderers price shall be deemed to include cost of all materials, tools and tackles, taxes, delivery charges etc. whether specifically mentioned or not. The tenderer shall also include in his price all taxes, duties or other levies (viz., Excise duty, Custom duty, VAT, DVAT, Service tax, GST etc.) which are legally leviable on the execution of work. The prices will remain firm & fixed during the currency of work. However in case of any statuary variation in Taxes/Duties after the last date of submission of Tender the same shall be adjusted.G

1.2. DEVIATION, EXTRA ITEMS / PRICING

The Officer shall have power to make alteration in, omissions from, additions to, or substitutions form the original specifications and instructions that may appear to him to be necessary or advisable during the progress of the work, the contractor shall be bound to carry out the works in accordance with any instructions given to him in writing signed by the Officer and such alterations, omissions, additions or substitutions shall form part of the contract as if originally provided therein and any altered, additional or substituted work which the contractor may be directed to do in the manner specified above as part of the works, shall be carried out by the contractor on the same conditions in all respects including price on which he agreed to do the main work except as hereafter provided.

1.3. EXTRA ITEMS / PRICING

In the case of extra item(s) the contractor may within fifteen days of receipt of order or occurrence of the item(s) claim rates, supported by proper analysis, for the work and the Officer shall within one month of the receipt of the claims supported by analysis, after giving consideration to the analysis of the rates submitted by the contractor, determine the rates on the basis of the market rates and the contractor shall be paid in accordance with the rates so determined.

1.4. PARALLEL WORK CLAUSE

SAU reserves right to enter into parallel work(s) simultaneously or at any time during the period of the contract with one or more tenderer(s) as may be deemed fit.

1.5. OTHER CONDITION TO BE ADHERE BY TENDERER

a. The work is to be carried out as per the specifications in the tender. The Tenderer shall clear the site after completion of work in all respect.

- b. The contractor shall comply with safety codes for Fire precaution, health requirement, scaffolds & ladders etc.
- c. No T & P shall be issued by SAU.
- d. All dismantled material for which credit is not being given in the tender shall be handed over to the site engineer stored at proper place.
- e. Contractor shall be fully responsible for safety of his workers and incase of any accident / mishap the entire responsibility shall be on the contractor.
- f. The work shall be executed without any loss / damage to the SAU's properties.

1.6. INTERPRETATION

In interpretation, the following orders shall be followed:-

- a. Technical Specifications
- b. Additional Conditions of Contract
- c. Special Conditions of Contract
- d. General Conditions of Contract

1.7. TERMINATION

- a. Being a standing offer, the work can be terminated from either side by serving 30-day notice to the other party. However, all the order placed before the date of serving of such notice will be valid and binding on both the parties. Further, the orders placed under the work can also be terminated individually and the same will not lead to automatic termination of work itself unless so specified.
- b. Termination of work order:- Notwithstanding anything elsewhere provided herein and in addition to any other right or remedy available to SAU under the work or otherwise including right of SAU to claim compensation for delay, SAU may, without prejudice to his right against contractor in respect of any delay, bad workmanship or otherwise or to any claims for damage in respect of any breaches of the contract and without prejudice to any rights or remedies under any of the provisions of this work or otherwise and whether the date for completion has or has not elapsed by intimation in writing, absolutely determine and terminate the contract.

Default or failure by the contractor in any of the under mentioned cases, including but not limited to the following shall be the basis of taking action under this clause of the contract.

- 1) Failure to provide at the job site, sufficient labor, material, equipment, machinery, and / or facilities, required for the proper and / or due execution of the work or any part thereof.
- 2) Failure to execute the works or any of them in accordance with the contract.

- 3) Disobedience of any order or instruction of the Site Engineer and /or Engineer- in charge.
- 4) Negligence in carrying out the work or carrying out of work found to be unsatisfactory by the SAU.
- 5) Abandonment of the works or any part thereof.
