INVITATION FOR BIDS

Supply & installation of CO2 Incubator

The South Asian University (SAU) is an International University sponsored by the eight member countries of the South Asian Association for Regional Cooperation (SAARC) viz. Afghanistan, Bangladesh, Bhutan, India, Maldives, Nepal, Pakistan and Sri Lanka.

Sealed quotations are invited from reputed authorized distributors/dealers/retailer, etc. for supply of & installation of Co2 Incubator for South Asian University addressed to "Assistant Registrar (E&P), Room No. ES 203, South Asian University, Rajpur Road, Maidan Garhi, New Delhi 110068 The detailed specifications are attached at Annexure-I.

Conditions for Submission of Bids

- 1. Sealed quotation should reach the University latest by 27.07.2023 up to 3.00 p.m. Quotation(s) received beyond the last date of submission will be rejected. All received bids will be opened on the same day at 3:30 pm. No quotation(s) will be entertained by e-mail or fax.
- In the event of the due date of receipt and opening of the tender being declared as a holiday for the University, then due date of receipt/opening of the tender will be the next working day at the same time.
- 3. Bidder shall be required to submit the Earnest Money Deposit (EMD) for an amount of Rs. 32000.00 in the form of Demand Draft Banker's cheque/Bank Guarantee which is refundable drawn in favour of South Asian University, payable at New Delhi.
- 4. The University reserves the right to split the order in view of time constraint or select certain items in single or multiple units and reject the others or all as mentioned in the schedule and to revise or alter the specifications before acceptance of any tender and accept or reject any or all tenders, wholly or partly or close the tender without assigning any reason whatsoever.
- 5. The tenderer while sending their tender should enclose a copy of the conditions stipulated duly certified and attested by them in token of accepting the tender conditions that they understood and accepted them in full. Tenders received without the certified copy of the conditions shall be rejected summarily.
- 6. The rates of the materials should be valid for at least six months for further purchase as well.
- 7. The loading, unloading at SAU and bringing the material up to the work location shall be responsibility of the contractor/supplier.
- 8. The rates shall be inclusive of transportation, loading, unloading & handling charges and nothing extra will be paid.

- 9. **TERMS OF DELIVERY**: All the supplies should be delivered & installed at LSES Building, South Asian University, Rajpur Road, Maidan Garhi, New Delhi 110068
- 10. **DATE OF DELIVERY**: The date of delivery shall strictly be adhered to, failing which the University reserves the right of not accepting the supplies and to charge suitable damages or to effect purchase at the supplier's cost and risk. If the supplier fails to supply the the goods on or before the above mentioned delivery date, compensation may be recovered at the rate of 1% of the cost of order for every weeks delay or fraction thereof subject to a maximum of 10% of the cost of goods. If and when required, the extension for date of delivery should be obtained with proper justification
- 11. **DISCREPANCY OR OMISSIONS**: The payments are made strictly on the basis of the payment terms of the contract/work order which will be mentioned below and the contractor/supplier is advised not to change anything over and above the amount stipulated in the work order. In the event of there being any discrepancy, the matter should first be referred to the undersigned for examination and if necessary issue of necessary amendments to the supply order before submission of the bill.
- 12. **INVOICE:** Along with the supplies, the supplier shall submit the invoice in duplicate that is pre-receipted and affixed with stamps, where necessary. Bills not conforming to all clauses are liable to be returned to the suppliers and responsibilities of delay in payment would rest with them.
- 13. **PAYMENT**: Will be made 100% when all the items have been delivered & installed against a particular order to the satisfaction of the University
- 14. The South Asian University is an International Organization declared by the Central Government in pursuance of Section 3 of the United Nations (Privileges and Immunities) Act, 1947 (46 of 1947) and is therefore entitled to claim refund of Goods and Services Tax (GST) paid on the procurement of Goods and/or Services.

Please ensure that our UIN is mentioned on all invoices raised on us for the goods and services supplied. The invoice raised should be in conformity with the various provisions of respective GST Acts and should include the following-

- The Invoice should be Tax Invoice;
- Name, address and GSTIN of the supplier;
- Invoice Number;
- Date of issue
- Name, address UIN of the recipient;
- HSN code of goods or Accounting Code of services (SAC);
- Description of goods or services;
- Quantity in case of goods and unit or Unique Quantity Code thereof;

- Place of supply along with the name of State, in case of a supply in the course of inter-State trade or commerce:
- Address of delivery where the same is different from the place of supply;
- Signature or digital signature of the supplier or his authorized representative.
- 15. PERFORMANCE SECURITY: The successful bidder shall be required to furnish a Performance Security of 5% of the total value of the contract within 14 days of the purchase order. Performance security may be furnished in the form of an Account Payee Demand Draft/ Fixed Deposit Receipt/ or a Bank Guarantee from any Scheduled Commercial Bank in an acceptable form to the University drawn in favour of "South Asian University", New Delhi. Performance security shall remain valid for a period of sixty days beyond the date of successful installation of the equipment and warranty period. No interest will be payable by SAU on the Performance Security.
- 16. DAMAGES / ACCIDENTS: If some major or minor damage happens to the given property under this work order during the period of execution, the contractor/supplier is liable to rectify the damage / damages at his own cost and cannot charge from the University. The contractor/supplier is liable for the safety of his own staff/labors while executing the work, if any accident happens to any of them the contactor will be responsible for that.
- 17. **ORDER CONFROMITY**: The items of works which are not found to be not up to the quality expected by the South Asian University & do not conform to the description/specifications laid down in the work order, will be rejected at the contractor/supplier's cost and risk.
- 18. **DISPUTES**: In case of any disputes, differences or objections connected with or arising out of the works awarded with this work order or the meaning or operation of any part of the terms, the matter shall be referred for arbitration to any officer appointed by the President of the South Asian University and whose decision shall be final and binding.

Annexure I Specifications for CO2 Incubator

- 1. Microprocessor controlled, stackable CO2 incubator with a minimum capacity of 150 Ltr, Power: 230V, 50Hz
- 2. Temperature Control Range 4°C above ambient 50°C with control increment: ±0.1°C
- 3. Incubator should be air-jacketed or have six-sided direct heating to provide stable temperature control. There should be no fan or fan-associated HEPA filters.
- 4. Should have excellent uniformity and rapid recovery with no over shoot event.
- 5. The CO2 control range should be from 0.1 to 20% with control accuracy and uniformity of ±0.1%. Infra-Red sensor for detection should be there.
- 6. It should have both acoustic and visual alarm systems. Screen should display system status, CO2 and temp status, and door open signs
- 7. Chamber Construction Type 304 stainless steel or superior. Inner chamber should be formed in single stainless-steel sheet with seamless design.
- 8. Should have minimum 3 adjustable height perforated shelves &a removable stainless steel humidity reservoir to achieve at least 90-95 % RH.
- 9. Should have Sterilization facility with dry heat at least 140 °C. There should be no need to remove IR sensor or filter during sterilization.
- 10. It should have internal glass door (single or segmented).
- 11. Machine should be supplied along with CO2 gas cylinder, dual stage regulator and suitable servo stabilizer for smooth functioning.
- 12. Instrument must be US/European UL listed & CE marked Certified. Certificates should be attached along with the Technical bid.
- 13. Warranty: Five Years (60months) on site comprehensive warranty with spare parts from date of installation including calibration services at prices fixed at the time of sale (5 calibration services over a span of 7 years).

At least 05 Nos. of end user satisfactory certificates should be enclosed along with Bid.

Quoted model should have at least 10 Nos. of installation in Central Government and State Governments labs.
